FIFTH WALL® Festival 2023 will take place in October 2023. This website domain is registered with/licensed with GoDaddy Operating Company, LLC. Submission of a dance film constitutes acceptance of the Entry Requirements and Guidelines, as well as the Terms and Conditions.

Participation Terms, Copyright and Conditions

- The FIFTH WALL® Competition is open to entries from all over the world. Each participant can submit only one video.
- Participants are not allowed to submit films entered to previous FIFTH WALL® Competitions.
- Participants are not allowed to submit films that have been part of non-competing categories of previous editions of FIFTH WALL®.
- The works must be short films in the genres of dance film (may be narrative, animation, experimental, documentary, etc.) with a film length of 5 to 30 mins, including all credits. All films must be shot in 16:9 (landscape orientation). This excludes works such as trailers or recordings of performances, one-minute films, commercials.
- Films must have a production date of 2023 or later.
- The works must be original and all rights must be held by the proponent. Applicants warrant
 that they are the copyright owners of any copyrighted material submitted. Applicants ensure
 that no third party rights will be infringed by FIFTH WALL®'s use of any of the submitted
 entries.
- The applicants warrant that they have secured full copyright and permissions in advance of submission, when applicable. If an action is brought against an applicant for infringement of copyright, FIFTH WALL® is held free and harmless of liability having had no participation in such act.
- The festival will not be accountable for any additional presentation costs. Please pay
 particular attention to ensure that music used has been cleared for copyright and any music
 presentation tariffs are not required. If an action is brought against an applicant for
 infringement of copyright, FIFTH WALL® is held free and harmless of liability having had no
 participation in such act.
- By participating in the festival, applicants cede the right to reproduce extracts and images of the submitted works to use, reproduce, amend, adapt, publish, distribute, execute and view the uploaded video (wholly or partially) on www.fifthwall.ph and/or other media channels (including but not limited to Facebook, Instagram, Youtube, Google +), web and mobile platform(s) of FIFTH WALL®. Participants waive all claims to remuneration where extracts of work are presented in such contexts. Any request to present extracts of work outside of such contexts by a third party will be communicated to the film rights holder by FIFTH WALL®.
- Once submitted, a film cannot be withdrawn for any reason.

Registration and Selection

- The entries must be submitted on or before August 20, 2023 (GMT+8), together with the completed registration form and requirements. The submitted video must be sent through a private (unlisted) link to the work, along with the password if necessary.
- International entries or submissions with a country of origin outside the Philippines are subject to a fee of USD 20. Nationality of films will be determined by the production's country of origin. The location of the majority of the film's production offices and personnel attributes to this signifier.
- Winning films will be selected by the jury appointed by FIFTH WALL®. The submitted works will not be returned to their proponents and will become part of the archive of the festival.
- A non-English film must have English subtitles for a better understanding of the piece.

Liability

FIFTH WALL® shall not be held liable for any injury or damage that may result from participation of the proponent or those involved in the film submitted. You fully accept and assume all responsibility for injury or damage that may result from preparation and participation in the Competition.
